**Classes Offered each day:** Instinct, Novice, Open, Senior, Master, Crazy 8 and Line Drive.  
Move-ups, Move Downs and Lateral moves are allowed between trials.

**Entry Fees:** - \$10 Instinct, \$20 Novice, Open and Line Drive. \$25 Senior, Master and Crazy 8. Late fee will be charged an additional \$5 per class.

**First class will start at 9:00 am**

**Running Order: **Friday and Sunday:** Instinct, Instinct, Novice, Novice, Open, Open, Crazy 8, Crazy 8, Senior, Senior and Master, Master. Line Drive is run throughout the day.**

**Saturday: Master, Master, Senior, Senior, Crazy 8, Crazy 8, Open, Open, Instinct, Instinct, Novice, Novice. Line Drive is run throughout the day.**

**Parking:** Follow the gravel driveway through the chain link fence with a gate. You may park anywhere to the left of the drive on the grass or take a right after the porta potty and park on the grass to your left. Please do not park on the gravel by the barn as that is an RV space. No parking in front of the barn or the grass across from it as that is the dog potty area. If there are no RV's behind the barn you may park behind it.

**Trial Site and Ring:** The trial grounds are on the other side of the driveway gate to the back of the property. The trial is held undercover in a Open Front 100 x 100 Barn. The ring is matted.

**Crating:** You may crate out of your vehicles. There is crating available on site up at the end of the gravel road in the haybarn that you may use. There is little shade, so bring your own pop-ups, shade screens, and fans.

**The Blind** is located inside the barn, size is 10x20 and has covered dividers between the seats. Blinds will be up to 6 dogs for Instinct, Novice and Open. Senior and Crazy 8s up to 5 dogs and Master will have 4 dogs.

Late and /or Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits.

Registration number and Barn Hunt Regulations (Competitor Rulebook) may be obtained on the **website**, [www.barnhunt.com](http://www.barnhunt.com) You must have a Barn Hunt # to enter. There also is a copy of all the rules on the table in the scoring area.

## Accepted Entries

**Entries** made without fees, barn hunt number, height or waivers signed will not be accepted. Owners are responsible for errors in making out entry forms, or whoever may have filled out the form and made such errors. Please check your confirmation carefully and make sure your information has been recorded correctly, especially your dog's Barn Hunt number.

**Entry fees** will be refunded after the closing date if a vet note is received, and runs can be filled by a wait list.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

**RTMK9A** reserves the right to refuse any entry for any reason. You will be notified by email and your entry fee will be returned.

**BITCH IN SEASON:** Bitches in season (**BIS**), may compete at Barn Hunt trials. They will be run at the end of each class. BIS must always wear pants/britches, including on the course, except when being pottied. Owners of BIS will crate/confine their dogs away from traffic and other dogs, and potty away from other competitors. The club will designate an area for BIS. Owners of BIS should make their condition known to the Trial Secretary prior to arrival, if possible. Entry fees for Bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded.

**Height divisions:** **Small Dogs** 15" and under, **Medium Dogs** 15.1 to 22", **Large Dogs** over 22". Dogs are measured at the option of the Judge.

Exhibitors are responsible for being ready to go from the staging area and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.

**FOOD:** There may be a short lunch break at the judge's discretion. There are fast food places 30 minutes away. There is also a small store/gas station about 8 minutes down the road where you can order a pizza and pick it up and also has some sandwiches. It's a small menu of food.

**AWARDS:** Ribbons will be awarded to those who obtain a ribbon at our trial. Qualifying ribbons will be awarded to all qualifiers in all classes, Placement 1<sup>st</sup> through 4<sup>th</sup>, High in Class, and the following Crazy 8 Titles: Bronze, Silver, Gold, Platinum, DBL Bronze, DBL Silver, DBL Gold, Double Platinum, Bonus and Super bonus.

**Volunteers:** are always welcome and appreciated. We couldn't put on a trial without you. If you don't know how to do a job we will train you. Worker Bucks will be handed out for classes that have 2 blinds or more. Worker bucks can be used towards entry fees for future trials. Can not be used for current trial earned in. Maximum amount that can be used for a trial is \$20.

**Restrooms: There are 2 porta potties on site.**

Exercise your dog responsibly. Please pick up after your dog at the show site and hotels. All dogs must be on leash except when in the ring hunting at the trial site. Please do not take your dog into the agility ring.

**DIRECTIONS TO TRIAL SITE: RV'S COMING IN THE BACK WAY DO NOT TAKE BARNETT BRIDGE RD. IF YOUR GPS TELLS YOU TO GO PAST IT AND IT WILL RE-DIRECT YOU. IT IS NOT A ROAD FOR RV'S.**

**From I-40 West**

Exit 320, Take a left onto Genesis (298N), Go 18.2 miles to Clarence Lee Rd (you will see a closed down store that says 4 Corners Market), take a left immediately after the market. Trial is at 2nd house on the left. GPS should bring you there.

**From I-40 East**

Exit 320, Take a right onto Genesis (298N), Go 18.2 miles to Clarence Lee Rd (you will see a closed down store that says 4 Corners Market), take a left immediately after the market. Trial is at 2nd house on the left. GPS should bring you there. If you are coming from I-40 your GPS may tell you to take Clarence Lee Rd earlier than the 18.2 mile mark, if there is not a market on the left than this is the 1st Clarence Lee Rd, you may take this also as Clarence Lee has 2 roads off of 298. If you are driving an RV then you'll want to make the 2nd Clarence Lee Rd on your left at the corner of the market as this gives you a better angle into our driveway.

**Trial Site is in Eastern Time Zone - Start times are EST.**
